Lights for Municipal Building - Supervisor Dennis Krotzer presented an estimate from Beaudoin Electrical Construction for the Municipal Building and requested that his office lights be repaired as they are not working correctly, seconded by Christina Price. Vote. All Yes. Motion Carried. It was also discussed to replace the Cemetery front Garage Lights with 6 incandescent A19 style bulbs with the LED Corn Lamps, 20 watts. There will be more estimated gathered to be presented at a future meeting.
