Board Meeting Minutes April 18th, 2022

The Baroda Township Board met on Monday April 18th, 2022 at 9091 First St in the Municipal Buildings meeting room, Baroda. Present were Board Members Dennis Krotzer, David Wolf, Christina Price, William Hurst and Larry Klug. There were 23 audience members. The meeting was opened at 7:00pm with a recitation of the Pledge of Allegiance.

<u>Guest -</u> Brian Snodgrass - Maintenance Interview with Brian Snodgrass took place.

Nimby Pond Fire Works – Mike and Joe the Owners of the fireworks display company presented that they plan to hold a fireworks Show on July 9th, 2022 at Nimby Pond. They were considering applying for the outdoor assembly permit with the Township in case they were going to go over 999 guests. They plan to speak with the Clerk at a later date. No fees will be charged at the gate it is a free show with donations accepted.

Library Report

Deb Christensen presented the Library Report –Deb reported the programs available in April.

Police Report- Supervisor Dennis Krotzer read the Police Report from Chief Shawn Martin with a total of 203 calls for March. Lake Twp. had 129, Baroda Twp. 45, Baroda Village 15 and 14 outside our jurisdiction.

Fire Department Report

Fire Chief Jeff Gaul gave the Fire Department report. He reported total incidents for the month of March 2022 were 6 and Year to Date is 12. He reported the total hours of training for March was 63.75 hours, monthly sessions 47.75 hours. Burn Permits requested 7, year to date total is 9.

Christina Price reported that the repair for GMC is waiting for the board to decide on whether to go with an off brand or GMC part. The Board decided to wait for the GMC part, since the truck was still drivable.

Christina Price reported that the Fire Department meeting room and kitchen floor needs to be fixed and Dennis Krotzer was to look into the repairs and get estimates.

Fire Chief Position – After further discussion Dennis Krotzer made a motion to reappoint Fire Chief Jeff Gaul for another year as Fire Chief, Christina Price. By Roll Call Vote – Voting Yes; , William Hurst, David Wolf, Dennis Krotzer and Christina Price. Voting No, Larry Klug. 4 to 1 Vote. Motion Carried

Fire Board – Currently the Fire Board is seeking to replace Stephanie Weimer as she is moving away for work. It was decided to post on our website, Facebook and post office.

Fire Department Driveway Cracks – It was reported that water was funneling down cracks in the driveway. After further discuss David Wolf said that there is not an issue and the way to check is to drag chains across and listen to the difference in sounds.

Police Millage Renewal Resolution – The Township Board reported what they voted on at the April 7th, 2022 Special Board Meeting to Approve the Ballot Language for the August 2, 2022 Primary. The board also mentioned they will have it up for discussion at each meeting to express the importance of passing this millage so the Township and Village can keep the Police protection. The new Millage would be set at 3.3089mills, which is an increase of 1.35mills per each \$1,000 of taxable valuation, as equalized.

Beaudoin Electrical Proposal for Hess Lake Park Lights – After further discussion it was decided to get an additional quote for adding lights to both poles that the Township owns per Clerk Christina Price as she reported what AEP told her.

Cemetery Ordinance – Christina Price gave a copy of the Cemetery Ordinance and mentioned items that are out date. Dennis Krotzer mentioned he would work on this with Christina and present a draft copy at the next board meeting.

ARPA- Dennis Krotzer reported that he is working on the April 30th, 2022 deadline for the ARPA Report.
