Board Meeting Minutes Draft December 19th, 2022

The Baroda Township Board met on Monday December 19th, 2022, at 9091 First St in the Municipal Buildings meeting room, Baroda. Present were Board Members Dennis Krotzer, Christina Price, William Hurst, Larry Klug and David Wolf. There were 10 audience members. The meeting was opened at 7:00pm with a recitation of the Pledge of Allegiance.

Library Report

The library report for November 2022. Baroda Check out Counts for November, 2022 was reported at 536 based on the population 2,835. Services: They will begin checking out Binge Boxes that are a collection of movies based on around a theme and will include 4-6 DVDs, Popcorn and candy. The library is beginning to partner with Kulture City. Kanopy is a video streaming service that will be available in the week.

<u>Police Report-</u> Dennis Krotzer read the Police Report from Chief Shawn Martin with a total of 225 calls for November 2022. Lake Twp. had 119, Baroda Twp. 74, Baroda Village 20 and 12 outside our jurisdiction. Lieutenant Wesley Koza was present to answer any audience or Board questions. Lake Township Contribution will be \$904,000.00 and Baroda Townships Contribution will be \$214,000.00.

Baroda Lake Police Budget Report was presented and after further discussion Dennis Krotzer made a motion to accept it as presented, seconded by David Wolf. Vote All-Yes. Motion Carried.

Fire Department Report

- Fire Chief Jeff Gaul gave the Fire Department report. He reported total incidents for the month of November 2022 were 5. He reported the total hours of training for November were 40 hours. Burn Permits requested 2, year to date total is 57. The Fire Department received about 60 smoke alarms on November 7th for Baroda Residents and two fans for use in the Station from Servpro. November 23rd, The Fire Department held a Thanksgiving Dinner together at the Hall.
- Assistant Fire Chief Chris Burch presented a paper on Floor repair at the Fire Stations Meeting rooms and Kitchen. He estimated about 15 hours with 3 fire fighters working. He also presented a report on the material cost to sand and paint the floor. After further discussion Dennis Krotzer made a motion to spend up to \$1000.00 on materials, seconded by Christina Price. Vote All – Yes. Motion Carried.
- Fire Chief Annual (RE) Appointment After further discussion it was decided to do the annual posting and collect any resumes of interested applicants.
- Fire Department New Roof Quote After further discussion Dennis Krotzer made a motion to go with the shingle quote for \$36,400.00 and to pay half this fiscal budget year and the rest in 2023-2024 out of the Fire Maintenance Fund, supported by Larry Klug.
