New Business –

Election Early Voting Resolution – Christina Price presented Resolution #23-11 9 Days of Early Voting. Lien on 9247 Holden Rd – Dennis Krotzer reported that 9247 Holden Rd is behind in water/sewer with Lake Township 2 years and would like to add that to taxes along with the property maintenance code violation of cutting the grass and the home being dangerous, needing to be boarded up. After further discussion David Wolf made a motion to add the water/sewer, boarding and lawn mowing the taxes, supported by Dennis Krotzer. Vote- All Yes. Motion Carried.

Cleveland Road Property- Roger Zilke was present mentioned the survey is complete and he plans to talk with Angie Story about the property split. Roger also mentioned that Hop Head farms is not interested in the 4.37acres that the Township is wanting to purchase.

Proposal Arnt Asphalt- After further Discussion David Wolf made a motion to approve the proposal from Arnt Asphalt as presented, supported by Dennis Krotzer. By Roll Call Vote – Voting Yes; William Hurst, David Wolf, Dennis Krotzer, and Christina Price. Absent Larry Klug. Voting No, None. Motion Carried
